Auckland Golf Inc is now calling for nominations for the position of Director of the Board. The first stage of the 2024 election process is the nomination of candidates. The nomination process is outlined in Rule 35 of the Auckland Golf Constitution and states that nominations for Board Members may be submitted by any Club within the Auckland District on the prescribed form below and with the nominee's consent.

The term for these Director positions is two (2) years through until 30 November 2026.

As set out in the Auckland Golf constitution, Board Directors must stand down at the conclusion of their term. These Directors may be nominated by a club re-election for further terms up to a maximum of four consecutive, two-year terms.

There are currently two (2) Directors who have their term expiring on 30 November 2024 and at least one of the Directors is not re-standing for election.
